## **PROGRAM OVERVIEW**

One of the primary mandates of BIRAC is “to *trigger, transform and tend biotech start-ups to convert innovative research of public and private sector into viable and competitive products and enterprises*”. To accomplish this, BIRAC has launched several schemes to promote the innovative research in biotech sector. Securing technological innovation through different regimes of Intellectual Property (IP) is an important aspect in the growth strategy for the knowledge economy.

BIRAC IP & Technology Management Cell is making considerable efforts to safeguard the Intellectual Property and to build a pipeline of Translatable technologies of BIRAC funded projects for further commercialization. To promote the innovation ecosystem in India and also to enable the commercialization of the technology, BIRAC offers a wide range of IP and Technology Management services to Start ups, SME’s and Academia under the program **BIRAC-PATH (Patenting & Technology Transfer for Harnessing Innovations)**.

## **A. SUPPORT UNDER BIRAC-PATH (PATENTING & TECHNOLOGY TRANSFER FOR HARNESSING INNOVATIONS)**

### **1. SCOPE OF SUPPORT FOR BIRAC-PATH**

The scope of funding under this program will be for Patent Searches, Patent drafting, filing in India and certain convention countries and their limited maintenance. This program is intended to provide assistance to BIRAC beneficiaries. The grantees, however, will continue to own the patent and will determine the ideal path to commercial exploitation of such inventions. To take this forward, BIRAC has empanelled technically competent and experienced IP & Technology Transfer (TT) firms who could provide assistance for patent drafting, filing and Commercialization of such technologies.

### **2. WHO CAN APPLY FOR PATH?**

The call is open for all grantees funded by BIRAC under its scheme.



- a. Biotechnology Ignition Grant (BIG)
- b. Contract Research Service (CRS)
- c. Small Business Innovation Research Initiative (SBIRI)
- d. Biotechnology Industry Partnership Programme (BIPP)
- e. Industry Innovation Program on Medical Electronics (IIPME)
- f. Social Innovation Programme for Products: Affordable & Relevant to Societal Health (SPARSH)
- g. Any other BIRAC beneficiaries

### 3. **ELIGIBILITY CRITERIA FOR PATH**

- Only post provisional patent application filed under BIRAC supported project/s are eligible to apply under this scheme except for Start-Ups as defined under “Start-Up Action Plan” by DIPP wherein the filing of provisional shall also be covered in the scope of support for BIRAC Start-Ups.
- Under the BIRAC-PATH, request for Patent drafting and filing support should be submitted by the BIRAC beneficiaries with-in-the first 9 (Nine) months from the date of filing the provisional patent application and not thereafter.
- BIRAC Funded Start-ups, Companies, SMEs and Academia
- Start-Up specific provisions in accordance with the “Start-Up Action Plan” by DIPP is stated below: “An entity shall be considered as a 'Start-up'-
  - a) *Up to five years from the date of its incorporation/registration,*
  - b) *If its turnover for any of the financial years has not exceeded Rupees 25 crore, and*
  - c) *It is working towards innovation, development, deployment or commercialization of new products, processes or services driven by technology or intellectual property;”*

### **B. BIRAC AS A FACILITATOR FOR START-UP INTELLECTUAL PROPERTY PROTECTION (SIPP)**

On January 16, 2016, Government of India announced the ***Start-Up India Action Plan wherein the Scheme for Start-up Intellectual Property Protection (SIPP)*** was also mentioned to facilitate the filing of Patents, Trademarks and Designs by innovative Start-ups through panel of facilitators appointed by DIPP. Under the Scheme for Start-up Intellectual Property Protection (SIPP), BIRAC has been appointed as a facilitator to facilitate the Biotech Start-Ups by providing the following services as assigned by DIPP.

#### **1. SCOPE OF SUPPORT BY BIRAC as Facilitator under SIPP\***

- Providing general advisory on different IPRs to Start-Ups on pro bona basis
- Providing information on protecting and promoting IPRs to Start-Ups in other countries on pro bono basis
- Providing assistance in filing and disposal of the IP applications related to patents under relevant Acts at the national IP offices under the CGPDTM
- Drafting complete/ provisional specifications for inventions of Start-Ups



- Preparing and filing responses to examination reports and other queries, notices or letters by the IP office
- Appearing on behalf of start-up at hearings-as may be scheduled
- Contesting opposition, if any, by other parties, and
- Ensuring final disposal of the IPR application

## **2. WHO CAN APPLY UNDER SIPP?**

Any Start-Ups (as defined under Start-up Action Plan) working in any area of Biotechnology and/or Life Sciences such as Bio-pharma, Vaccine, Drug Development, Agriculture, Environmental Biotechnology, Device and Diagnostics and Industrial Biotechnology, may select BIRAC as Facilitator under SIPP scheme to protect their IP.

**Start-ups as defined under Start-up Action Plan:** Start-Up specific provisions in accordance with the “Start-Up Action Plan” by DIPP are stated below: “An entity shall be considered as a 'Start-up'-

- a) Up to five years from the date of its incorporation/registration,
- b) If its turnover for any of the financial years has not exceeded Rupees 25 crore, and
- c) It is working towards innovation, development, deployment or commercialization of new products, processes or services driven by technology or intellectual property;”
