M/s Biotechnology Industry Research Assistance Council (hereinafter referred to as **BIRAC**) is a not-for-profit Section 8, Schedule B, Public Sector Enterprise, set up by Department of Biotechnology (hereinafter referred to as **DBT**), Ministry of Science & Technology, Government of India having its office at 5th Floor, NSIC Business Park, NSIC Bhawan, Okhla Industrial Estate, New Delhi – 110020 hereby serves this Notice for invocation of Arbitration upon you as stated here under:

- 1. That this is with regard to the Loan facility availed by M/s Maps Enzymes Limited (hereinafter referred to as Company).
- 2. That Department of Biotechnology (DBT), Ministry of Science & Technology, Government of India has sanctioned a loan of Rs. 8.50 Lakhs vide Sanction Order dated 03/08/2007 for the project entitled "Development of a cost effective process for phytase production and its application studies (Phase I)" (Ref. No. BT/04(SBIRI)/89/2006 PID), and the terms of the loan were governed by the Agreement dated 01/08/2007 as entered by and between DBT and Company.
